### **HCM Honors**

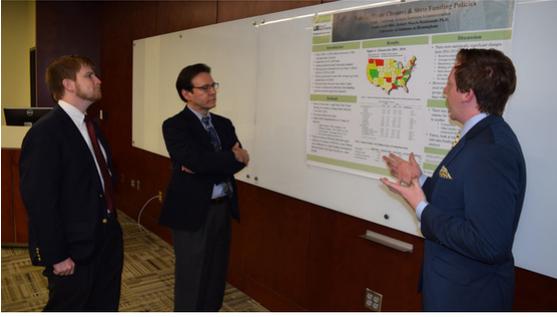

### MSHA students' Friday in the ER

The MSHA program is fulfilling our mission of "developing leaders to shape tomorrow's healthcare" through continuing to innovate our approaches to teaching and learning.

Recently, our students found themselves at the ER on a Friday night – without ever leaving their classroom.

We implemented a simulation called "Friday Night at the ER" in the Operations Management course. The game was a fun way for students to learn systems thinking, collaboration and data-driven decision-making.

### Further Enhancing the Classroom Experience

- MSHA students participated for the first time in a poverty simulation with the Office of Interprofessional Simulation for Innovative Clinical Practice at UAB. It was designed to raise awareness of social determinants of health. Students were divided into families with the goal of making it through a month of working and paying bills while facing the challenges of a low-income family.
- In the Capstone Course, students are participating in management simulations and interprofessional simulations. In the management simulations, students experience a variety of management situations involving employees and physicians. This has provided an opportunity to get our alumni involved in providing feedback and instruction. Beth Cain and

Jordan DeMoss (MSHA Class 39), Rett Grover and Martin Smith (MSHA Class 43) and Mark Todd (E 49) were all alumni participants.

- Finally, MSHA students participated in a series of simulations with fourth year medical students as part of their “Residency Prep Week.” These simulations took place in the clinical simulation lab at UAB Hospital, and they allowed our MSHA students to collaborate with future physicians on clinical and administrative issues. Both MSHA and medical students alike learn to see things from a different perspective through this experience.

### Book Discussion Inspires Actions

After meeting in a book discussion during an EMSHA campus session in Fall 2016, Vic Dippenaar, MDIV., M.Th., (EMSHA Class 52) and Jamie Wade, MS, SLP-CCC, MSHA (EMSHA Class 48) were inspired to start a pilot project of a small leadership accountability group.

### Saudi students propose big ideas for Capstone

Seven multi-disciplinary teams in the UAB School of Health Professions’ Master of Science in Health Administration – International Track program based in Dammam, Saudi Arabia, presented big ideas to improve health care in the Kingdom.

One of those teams created a proposal to establish a Saudi equivalent of the United States’ National Institutes of Health (NIH).

Another major proposal from a team of executive students was an innovative way to reduce cardiac mortality during Hajj season. The annual pilgrimage to Mecca is the largest gathering of humans on the planet and each year there are an estimated 700 – 1,000 cardiac episodes.

### Capstone Project Impacts Patient Care

In December 2016, Kathy Monroe, M.D., professor and research director, Pediatric Emergency Medicine at UAB, successfully completed her capstone project "Timely Antibiotic Dosing for Febrile Neutropenia Patients in a Pediatric Emergency Department".

"The staff were very supportive and my thesis resulted in a true quality improvement for our Emergency Department," said Monroe. "We were able to improve our time to antibiotics to less than an hour in high risk pediatric patients with fever and neutropenia to 90-100%. The skills I gained during the HQS process were instrumental in getting this project to success!"

At the end of the course sequencing in the MSHQS program, students integrate their educational acquisition to improve quality and patient safety outcomes in their professional workplace through a capstone project.
